SUBJECT: Standard Agreement 07-H9026 between County of Riverside and Community Access Center

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve and authorize Chair to execute the following: Standard Agreement 07-H9026 and Professional Service Agreement between County of Riverside and Community Access Center.
- 2) Direct Clerk of the Board to return the Standard Agreement and Professional Service Agreement to the Office on Aging for further processing.

BACKGROUND: Riverside County Office on Aging, in partnership with Community Access Center (CAC) was awarded a multiple year California Aging and Disability Resource Center Program Grant by the California Health and Human Services Agency. This grant supports an initiative to provide older adults, persons with disabilities, and caregivers with comprehensive information, assistance and referrals to long-term care services. Community Access Center, in collaboration with Riverside County Office on Aging will: 1) train discharge planners, social workers, nursing, and in-home staff; 2) educate nursing home residents and/or individuals at risk of entering an institution; 3) identify community based resources used in assisting with transition from nursing homes to long term care community based living; and 4) share resources with Riverside County Office on Aging for inclusion in the CalCareNet web-based information system pilot.

The term of this multiple year agreement with Community Access Center is May 1, 2008 through April 30, 2011; the maximum amount payable under this agreement shall not exceed \$130,011. Shown below is a breakdown of the amounts per each fiscal year:

2007/08	\$7,223
2008/09	\$43,337
2009/10	\$43,337
2010/11	\$36,114

Funds unexpended from fiscal year 2007/08 will be allowed to be carried forward into fiscal year 2008/09, if necessary, to enable Community Access Center to meet the requirements of the Scope of Work (refer to Exhibit A) included with this agreement.
