RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve Resolution No. 2008-417, Authorization to Purchase an Easement for the Non-Exclusive access over San Bernardino County Assessor's Parcel Number 1178-061-01-0000 located in San Bernardino County;
2. Authorize the Department of Facilities Management to negotiate the purchase of an Access and Landscape Easement as shown in Exhibit "A" at a price of \$15,000, plus transaction costs not to exceed \$5,000;
3. Approve the Agreement of Purchase and Sale and Joint Escrow Instructions and authorize the Chairman to execute the documents necessary to complete the purchase; and

4. Authorize the Director of the Department of Facilities Management or his designee to execute any other documents and administer all actions necessary to complete this transaction.

BACKGROUND:

The Board of Supervisors approved a final California Environmental Quality Act (CEQA) Final Environmental Impact Report (FEIR) and Mitigation Program for Public Safety Enterprise Communications (PSEC) project site acquisition and development on September 2, 2008 allowing site acquisition and construction to start. The FEIR and CEQA process addressed site specific and cumulative impacts, mitigation requirements and unavoidable environmental impacts stemming from the site acquisition, construction and operation of the proposed public safety communications project. The requested easement is located on Blue Mountain on the Grand Terrace and Colton Line. The Blue Mountain site provides coverage to Highgrove, I-215, SR60 and Reche Canyon. This easement and second easement allows construction and maintenance access for a replacement of a leased radio site. A standard form Purchase and Sale Agreement approved by County Counsel is being used in these site purchases. All associated compensation to Seller and the transaction costs for the project will be fully funded through the currently appropriated 2008/09 PSEC budget.

FINANCIAL DATA:

All costs associated with these acquisitions are fully funded through the PSEC budget for FY 2008/09; thus, no additional net county cost will be incurred as a result of these transactions.
