SUBJECT: Third (3rd^h) Amendment to the Professional Medical Services Agreement between the County of Riverside and Rady Children's Hospital, San Diego

RECOMMENDED MOTION:

- 1) Ratify the third (3rd) amendment to the agreement with Rady Children's Hospital effective, November 1, 2006;
- 2) Authorize the Chairperson to sign two (2) copies of the amendment;
- 3) Retain one (1) copy and return one (1) copy of the executed amendment to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On October 25, 2005, Agenda No. 3.29, the Board of Supervisors approved the agreement between the County of Riverside and Rady Children's Hospital-San Diego formerly known as Children's Hospital—San Diego, through its Chadwick Center to provide on-site training programs for the prevention, identification, and treatment of neglected and abused children for the Hospital.

The amendment deletes the original term and replaces it with language permitting automatic continuation on a year-to-year basis. The amendment revises the rate paid for Medical Director and preceptorship services.
