4. Authorize the Director of DPSS to administer the agreement with MFI Recovery Center.

**SUBJECT: HOUSING AND URBAN DEVELOPMENT GRANT AGREEMENT—
MFI Recovery Center**

BACKGROUND:

On May 22, 2007 (Agenda Item 3.32), the Board authorized DPSS to submit an application for Homeless Assistance funds under the Supportive Housing Program to the U.S. Department of Housing and Urban Development, which included A Woman's Place renewal project sponsored by MFI Recovery Center of Riverside.

A Woman's Place transitional housing project is a 14 unit, 34 bed program in which residents (14 adults and 20 children) may stay up to 24 months. One hundred percent of residents in this program are homeless and chronic substance abusers. Approximately 25% are victims of domestic violence. This Agreement provides funding for supportive services, operations, administrative costs, and participation in the Homeless Management Information System. MFI has a cash match obligation of approximately \$26,624. It is anticipated that at least 63.5% of those housed will move on to permanent housing and that at least 19% will exit with employment.

According to the latest Annual Progress Report submitted by MFI for the time period 12/01/2006 through 11/30/2007, 10 people entered the program and 11 exited the program. Of those exiting, 100% moved into permanent housing and 73% gained income from employment.

There are no changes to the persons to be served, the service site(s), or service modalities between this Agreement and the expiring Agreement.

The current one-year grant ends on November 30, 2008.
