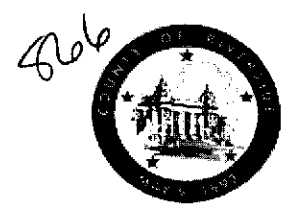

On September 18, 2008, the Mayor of La Quinta executed the First Amendment to the City's law enforcement services Agreement with the County Sheriff's Department. In this Amendment, the City modified the level of service provided by the Sheriff's Department, with the addition of a Lieutenant, four Deputy Sheriff positions for daily patrol, and a Community Services Officer II. County Counsel has approved the Amendment as to form.

Based on projected start date for this service addition, staff estimates the FY 2008-09 budget for the increased service will amount to \$530,700. Costs for this service increase will be recovered through Board-approved rates.

The 800 MHz radio equipment specified conforms to selected County Technology Standards and will be purchased through the Information Technology Department.
