BACKGROUND: By Minute Order 3.63 of June 3, 2008, the Board entered into an agreement with DBX, Inc. of Temecula, CA for the construction of traffic signal and lighting at Sumner Avenue and Orange Street and at Hamner Avenue and Swan Lake Mobile Home Park, in the Eastvale area of Riverside County. The authorized amount of the contract was \$264,071. The total amended contract amount (including quantity adjustments) is \$262,137.60 which is .7% less than the originally authorized amount.

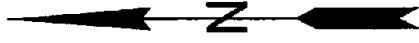

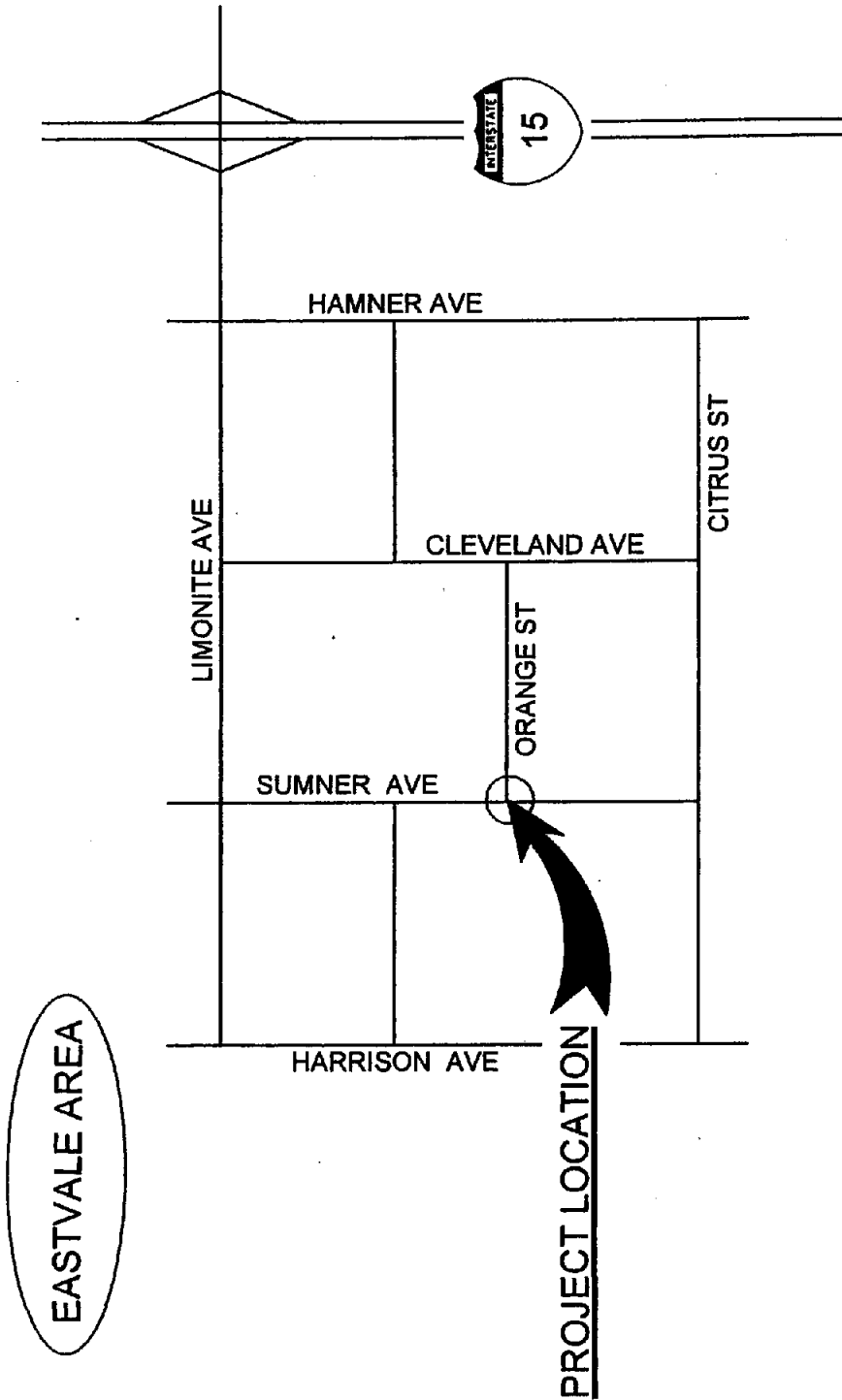

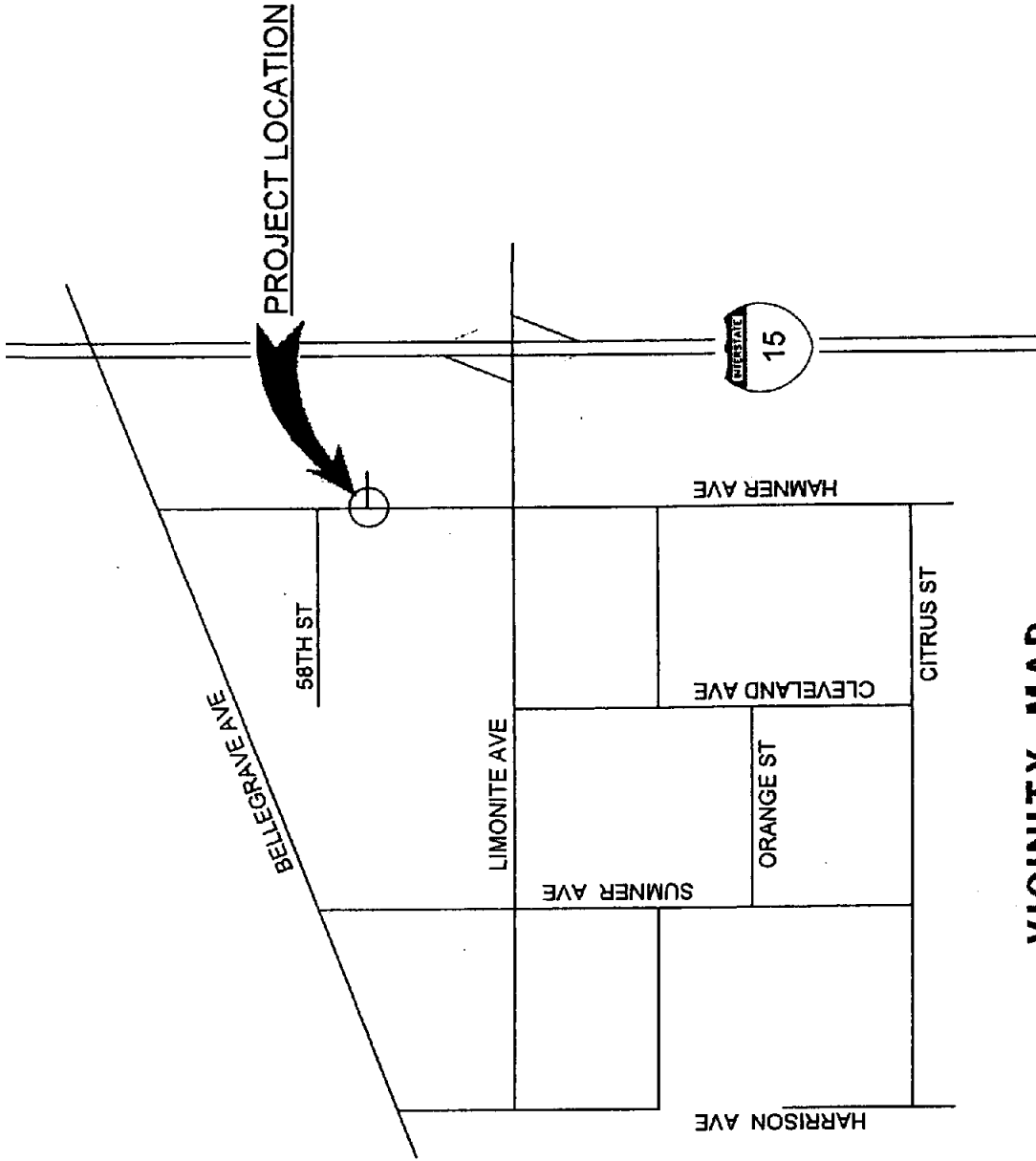
LOCATION MAP
