SUBJECT: Housing Opportunities for Persons with AIDS (HOPWA) Agreement between the Housing Authority of the County of Riverside (Project Sponsor) and the City of Riverside (Grantee)

RECOMMENDED MOTION: That the Board of Commissioners:

1. Approve the agreement between the Housing Authority of the County of Riverside and the City of Riverside to allow the Housing Authority to serve as the HOPWA Project Sponsor for the County of Riverside;
2. Authorize the Chairman to execute the attached 2008-2009 HOPWA Agreement; and
3. Authorize the Executive Director or designee to take all necessary steps to implement this Agreement including, but not limited to, signing subsequent necessary and relevant documents.

BACKGROUND: The U.S. Department of Housing and Urban Development (HUD) has sponsored a program titled Housing Opportunities for Persons with AIDS (HOPWA). This program provides localities with financial resources to devise long-term, comprehensive strategies for meeting the housing needs of low-income, HIV-positive individuals and their families. The City of Riverside, as grantee for the Riverside/San Bernardino County service area, has awarded the Housing Authority \$1,019,082 to coordinate HOPWA services within Riverside County during PY 08/09.
