**SUBJECT:** Ratify multi-year Student Affiliation Agreements with four Universities/Colleges as listed below.

**RECOMMENDED MOTION:**

That the Board of Supervisors:

- 1) Ratify multi-year agreements between the four Universities/Colleges listed below and the Community Health Agency/Department of Public Health for the performance period of July 1, 2008 through June 30, 2013;
- 2) Authorize the Chairperson of the Board of Supervisors to sign the Agreements; and
- 3) Authorize the Director of the Department of Public Health to sign subsequent amendments to these agreements not to exceed the approved performance period.

**BACKGROUND:** These agreements provide for the assignment of students enrolled in the Universities and College's School of Nursing, Public Health Program, Health Sciences, Biology Department, College of Health and Dietetic Programs to County Health Clinics. The students provide the County with valuable assistance at no cost. In addition, the students gain much needed on-the-job training and experience.
