BACKGROUND: On July 1, 2008, the County entered into a contract with Southwest Construction Inc., for the construction of the Apron Rehabilitation Project for the Jacqueline Cochran Regional Airport. The project consisted of rehabilitating and refurbishing the aircraft holding apron located on the Signature Fixed Base Operator (FBO) Leasehold. The project was completed on November 1, 2008, and the airport has been returned to its full operational capacity.
