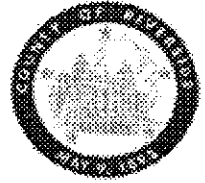

RECOMMENDED MOTION: Move that:

Departmental Concurrence

- (1) The substandard structure (house) on the real property located at 45658 Partridge Street, Banning Riverside County, California, APN: 545-182-047, be declared a public nuisance and a violation of Riverside County Ordinance Nos. 457, which does not permit substandard structures on the property, and 541 which prohibits accumulated rubbish.
- (2) Owner, Rod Nielson, or whoever has possession and control of the subject real property, be directed to abate the substandard structure on the property by rehabilitating, removing and/or demolishing the same from the real property, including the removal and disposal of all structural debris and materials, within ninety (90) days, in strict accordance with Riverside County Ordinance No. 457.

- (3) The owner be ordered to ascertain the existence or non-existence of asbestos containing materials in said structures by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- (4) The accumulation of rubbish on the real property located at 45658 Partridge Street, Banning, Riverside County, California, APN: 545-182-047, be declared a public nuisance and a violation of Riverside County Ordinance No. 541 which does not permit the accumulation of rubbish on the property.
- (5) The owner, or whoever has possession and control of the subject real property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days.
- (6) If the owner, or whoever has possession or control of the real property, does not take the above described actions within ninety (90) days of the date of the Board's Order to Abate, the accumulated rubbish, substandard structure and contents therein shall be abated and disposed of by representatives of the Riverside County Code Enforcement Department, a contractor or the Sheriff's Department upon receipt of an owner's consent or a Court Order where necessary under applicable law authorizing entry onto The Property.
- (7) The reasonable cost of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance Nos. 457, 541 and 725.
- (5) County Counsel be directed to prepare the necessary Findings of Facts and Conclusions that the accumulation of rubbish and substandard structure on the real property are declared to be in violation of Riverside County Ordinance Nos. 457 and 541, and a public nuisance, and further, to prepare an Order to Abate and Order and Findings for approval by the Board.

JUSTIFICATION:

1. On April 25, 2008, Code Enforcement Officer Wayne Durant conducted an initial inspection of The Property. The inspection revealed a substandard structure and an accumulation of rubbish on the subject property in violation of Riverside County Ordinance Nos. 457 and 541. The substandard conditions of the structure included, but were not limited to: extensive fire damage, lack of adequate heating facility; deteriorated or inadequate foundation; members of walls, partitions or other vertical supports that split, lean, list or buckle due to defective material or deterioration; dampness of habitable room(s); and defective or deteriorated flooring or floor supports. The inspection also revealed accumulated rubbish which measured 1,500 square feet on the property.

2. Subsequent inspections of the above-described real property on July 7, 2008, September 2, 2008 and October 27, 2008, revealed the property continues to be in violation of Riverside County Ordinance Nos. 457 and 541.
3. Staff and the Code Enforcement Department have complied with the requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the abatement of the substandard structure and accumulated rubbish.
