BACKGROUND:

In 2003, CSD provided \$45,000 in Community Services Block Grant (CSBG) Discretionary Funds to CAP Riverside to supply relief to County of Riverside residents impacted by the October and November wildfires. In 2006, CAP Riverside received \$75,000 in CSBG Discretionary Funds to supply relief to County residents impacted by the Esperanza and Lookout Fires. CAP Riverside distributed air purifiers, vouchers to department and grocery stores, and provided utility bill payment assistance and shelter/rental assistance.

Again, CSD is providing \$26,000 in CSBG Discretionary Funds to provide relief to County residents impacted by the Triangle Complex Fire. CAP Riverside will provide vouchers for food, clothing, and personal items, temporary shelter/housing assistance, gas cards for transportation, and miscellaneous needs.

Therefore, the Executive Director of CAP Riverside requests the Board to approve Agreement #09F-5009 not to exceed \$26,000, covering the term October 21, 2008 through October 31, 2009.

FINANCIAL IMPACT: No County General Funds will be required.
