
SUBJECT: RESOLUTION NO. 2009-050 Sky Valley Community Council boundary change

RECOMMENDED MOTION: That the Board of Supervisors approve Resolution No. 2009-050 altering boundary of the Sky Valley Community Council area.

District # 4

JUSTIFICATION: The Sky Valley Community Council was established in 1993. Community Councils have been established in 13 unincorporated communities in eastern Riverside County and have proven very successful in providing input to the Board of Supervisors on matters of concern to the residents. They serve the purpose of advising the Board on matters pertaining to public health, safety, welfare, public works and planning.

The community has indicated concern over development pressures from the west, and would like to have additional territory within the Council boundaries in order to have more comprehensive input on potential development in the area.

4 **A RESOLUTION OF THE COUNTY OF RIVERSIDE CHANGING**  
5 **THE BOUNDARY OF THE SKY VALLEY COMMUNITY COUNCIL**

6 **WHEREAS**, Government Code Section 31010 allows for the creation of an  
7 advisory council within unincorporated territory for the purpose of advising the Board of  
Supervisors on matters including, but not limited to, public health, safety, welfare, public  
works, and planning;

8 **WHEREAS**, on March 19, 1993 by Resolution 93-109, the Board of Supervisors  
9 created the Sky Valley Community Council; and

10 **WHEREAS**, the members of the community of Sky Valley indicated concern over  
11 potential encroaching development from the west and voiced a desire to have further  
advisory input for the area between Sky Valley and the Desert Edge community; and

12 **WHEREAS**, at their November 12, 2008 meeting, the Sky Valley Community  
13 Council voted unanimously to recommend to Supervisor Wilson the addition of three land  
sections to the Sky Valley area: T3S R5E Sections 01, 13, and 24, making Bennett Road  
the western boundary of the Sky Valley Community Council;

14 **NOW THEREFORE, BE IT RESOLVED AND ORDERED** by the Board of  
15 Supervisors of the County of Riverside, State of California, in regular session assembled  
on January 27, 2009, that the Sky Valley Community Council geographic boundary is  
16 expanded westward to Bennett Road.
