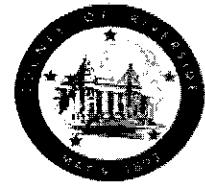

**SUBJECT:** Approval of the First Amendment to the FY 2008-09 School Resource Officers Agreement with the Lake Elsinore Unified School District

**RECOMMENDED MOTION:** Move that the Board of Supervisors approve the First Amendment to the FY 2008-09 Agreement for School Resource Officers (SRO's) with the Lake Elsinore Unified School District, and authorize the Chairperson to sign all copies.

**BACKGROUND:** On November 20, 2008, the Lake Elsinore Unified School District Board approved the execution of the First Amendment to the FY 2008-09 Agreement for the Sheriff's provision of law enforcement services. This Amendment adds an SRO, bringing the total number of SRO's on the District's campuses to six.

The City of Lake Elsinore recently reduced its level of contract law enforcement services, which included the deletion of a Deputy/SRO position (12/16/08 3.49). Upon hearing of the City's planned service reduction, the school district indicated that it would fund the position for the remainder of the school year. Consequently, the Sheriff's Department does not require an additional Deputy position to meet this contractual obligation.

All costs will be fully recovered through Board-approved contract rates. County Counsel has approved the document as to form.
