SUBJECT: Approval of the Provider Contract Agreements between United Concordia Companies, Inc., Anthem Blue Cross, Delta Dental of California, and Community Health Agency/Department of Public Health, Rubidoux Dental Clinic.

BACKGROUND: The County of Riverside, Department of Public Health operates the Rubidoux Dental Clinic. The Rubidoux Dental Clinic currently provides dental care services to Denti-Cal patients on a sliding fee schedule. The department will establish additional contracts with commercial carriers including United Concordia Company, Inc., Anthem Blue Cross, and Delta Dental of California, which will provide reimbursement for services to insured members who seek services at the Rubidoux Dental Clinic.

JUSTIFICATION: This agreement will increase revenue by providing dental services to the United Concordia Company, Inc., Anthem Blue Cross, and Delta Dental of California subscribers and their families. United Concordia, Anthem Blue Cross, and Delta Dental of California, will direct their subscribers and their families to our Rubidoux Dental Clinic. Subscribers will pay fewer out-of-pocket expenses by going to a contracted provider.
