RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the State Standard Agreement #09-00294 with the California Department of Corrections and Rehabilitation; and
- 2) Authorize the Chairperson to sign five (5) copies of the agreement; and
- 3) Direct the Clerk of the Board to return all five (5) copies of the signed originals to RCRMC Administration. Upon final approval, a fully executed agreement will be returned to the Clerk of the Board; and
- 4) Direct the Clerk of the Board to hold this agreement as a confidential document, not subject to release under the Public Records Act, and Health and Safety Code Section 1457, (C) (1).

BACKGROUND: The California Department of Corrections and Rehabilitation (CDCR) and the hospital have negotiated an agreement for inpatient, outpatient and emergency room medical services provided to CDCR inmates from the state institutions. The term of this agreement will expire as of June 30, 2010.
