**SUBJECT:** Amendment to the Per Diem Hospital Agreement between the County of Riverside and Molina Healthcare of California ("Molina")

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Amendment to the Riverside County Regional Medical Center (RCRMC) hospital agreement with the Molina effective October 1, 2008;
- 2) Authorize the Chairperson to sign two (2) copies of the amendment;
- 3) Retain one (1) copy and return one (1) copy of the executed amendment to Riverside County Regional Medical Center (RCRMC) for distribution.

**BACKGROUND:** On August 13, 1996, Agenda No. 3.27, the Board of Supervisors approved the hospital per diem agreement between the Hospital and Molina to provide Hospital services. This Amendment will allow RCRMC to participate in a supplemental Managed Care payment program which will provide additional funding to public hospitals. The non federal share will be provided through an intergovernmental transfer to the state similar to the DSH component of the Section 1115 Medi-Cal financing waiver. The net benefit to RCRMC will be approximately \$2 million this fiscal year.
