RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Agreement (08-1055) between San Bernardino County, Department of Health and the County of Riverside Community Health Agency, Department of Public Health for the performance period of October 21, 2008 through March 31, 2010 in the amount of \$235,620.
- 2) Ratify the Amendment (08-1055, A-1) between San Bernardino County, Department of Health and the County of Riverside Community Health Agency, Department of Public Health for an additional amount of \$35,550, for a total contract amount of \$271,170; and
- 3) Authorize the Chairperson to sign three (3) originals of said Agreement (08-1055) and Amendment 08-1055, A-1) on behalf of the County.

BACKGROUND: (Continued)

The mission of the HIV Program is to prevent and reduce the spread of HIV infection through accessible education, intervention, and support services provided in a sensitive and culturally appropriate manner.

The Riverside County HIV Program provides an array of HIV Prevention and care services for people living in Riverside County. The HIV Program continually monitors changes in the HIV epidemic and strives to develop highly effective strategies based on current findings to impact HIV infection rates, treatment, and client access to care. The Prevention with Positives Program functions as a key component of the Riverside County HIV Program to reduce transmission of HIV by promoting awareness and increasing access and utilization of HIV Program services. This amendment provides funding to assess the provision and access of Prevention with Positives services in Riverside County. Funds will be used to develop a specialized needs assessment of clients and providers and to develop a social marketing campaign based on survey results to maximize the utilization of Prevention with Positives services.

FINANCIAL INFORMATION:

The Master Grant Agreement is 100% funded by the State of California Department of Public Health Services. This grant does not require any County funds.

JUSTIFICATION FOR DELAY: *The Department of Public Health recently received this amendment on February 9, 2009, from the State of California Department of Public Health. This Form 11 and attachments were subsequently submitted through the County's approval process.*
