SUBJECT: El Sobrante Landfill Citizens Oversight Committee Annual Report for 2008

RECOMMENDED MOTION: That the Board of Supervisors:

1. Receive and file the 2008 Annual Report of the El Sobrante Landfill Citizens Oversight Committee; and
2. Approve the Citizen's Oversight Committee's recommendation to install anti-illegal dumping signs in the Temescal Valley and El Cerrito areas, using local mitigation monies set aside through the Second El Sobrante Landfill Agreement to fund the sign installation work by the Transportation Department.

BACKGROUND: Per Resolution No. 2005-148 Adopting Uniform Rules and Procedures for Advisory Committees, Board and Commissions of the County of Riverside and Board Policy A-21, advisory groups to the Board are required to file an annual report of its activities. The 2008 Annual Report of the El Sobrante Landfill Citizens Oversight Committee (COC) is attached.

On October 19, 2004 the Board approved the recommendation of the COC to utilize local mitigation monies set aside through the Second El Sobrante Landfill Agreement toward efforts to prevent illegal dumping in the Temescal Valley area and authorized the COC to develop an illegal dumping prevention program. Working collaboratively with the Code Enforcement Department, the COC has created anti-illegal dumping signs. The COC and Code Enforcement have solicited a quote from the County Transportation Department to install the signs (initially about 75) throughout the Temescal Valley and El Cerrito areas in an amount not to exceed \$10,000.

Meetings:

The Riverside County El Sobrante Landfill Citizens Oversight Committee met on October 15, 2008.

Actions Taken:

Following a review of the El Sobrante Landfill Annual Report for 2007, the Committee concurred with the Administrative Review Committee's finding that the El Sobrante Landfill is in compliance with the El Sobrante Landfill Second Agreement (dated September 1, 1998, amended July 1, 2003 and March 13, 2007), and recommended filing the Annual Monitoring Report for 2007 with the County Board of Supervisors on December 16, 2008.

The Committee formed subcommittees to work with Code Enforcement staff to identify proper locations to place illegal dumping signs in the Temescal Valley and El Cerrito areas.
