**RECOMMENDED MOTION:** That the Board approve election services and consolidation of a municipal election for the May 19, 2009 Consolidated Statewide Special Election.

**BACKGROUND:** California Elections Code §§ 10002, 10402, and 10403 allow local jurisdictions to request that the Board of Supervisors approve the Registrar of Voters to conduct and consolidate elections with a statewide election by submitting a resolution requesting these services. The City of Desert Hot Springs complied with this requirement and requests the Registrar of Voters to conduct and consolidate their election with the Statewide Special Election.
