**SUBJECT:** Approval of the Fifth (5<sup>th</sup>) Amendment to the Professional Medical Services Agreement between the County of Riverside and Chander P. Malhotra, M.D., Inc.

The professional services agreement is now further amended extending the term of the professional services agreement for an additional year with no increase in cost.

**FIFTH AMENDMENT**

That certain Agreement between the County of Riverside (COUNTY) on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Chander P. Malhotra, M.D., Inc. (CONTRACTOR) dated February 19, 2002, amended effective February 19, 2004, July 1, 2006, February 19, 2007 and July 1, 2008 is hereby further amended effective July 1, 2009 pursuant to the following:

1. Delete the first (1<sup>st</sup>) sentence from Section 4.1 and replace with the following:

“This Agreement will be effective June 20, 2009 through June 30, 2010, unless terminated as otherwise provided herein.”

All other terms and conditions of this Agreement are to remain unchanged.
