RECOMMENDED MOTION: Adopt Resolution No. 2009-176 Notice of Intention to Change the  
Name of Marius Way to Herbsville Court

BACKGROUND: 911 Emergency Services has requested this street name change because  
there are two roads in close proximity with very similar names, in the French Valley area, Marius  
Way, and Marius Avenue. The three adjacent property owners have been notified of the  
proposed name change and were given the opportunity to suggest a new name for the street.  
Responses were received from two property owners with suggestions for new names. All  
suggested names were submitted for review and the name selected was Herbsville Court. The  
Transportation Department has not received any opposition.

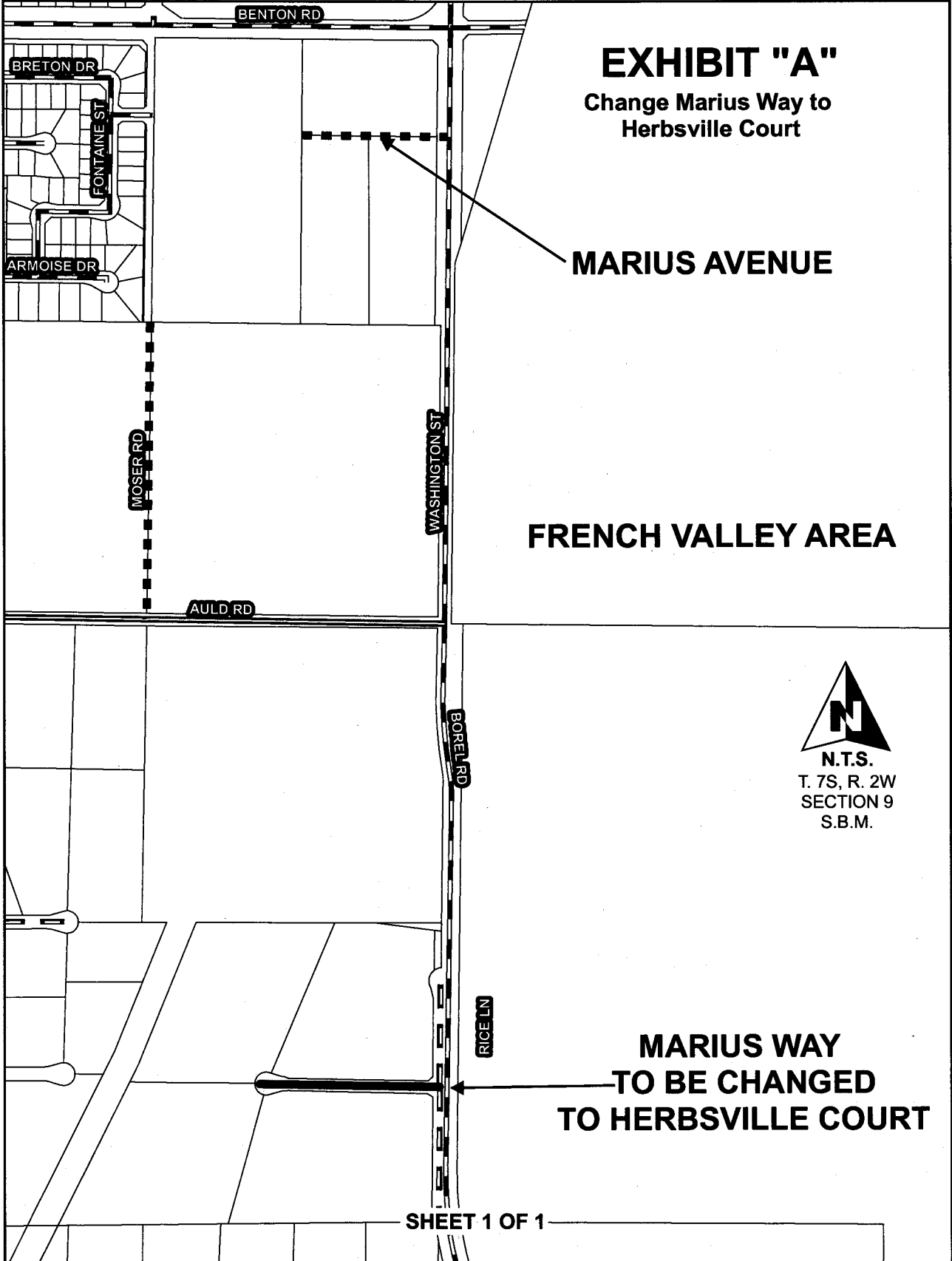

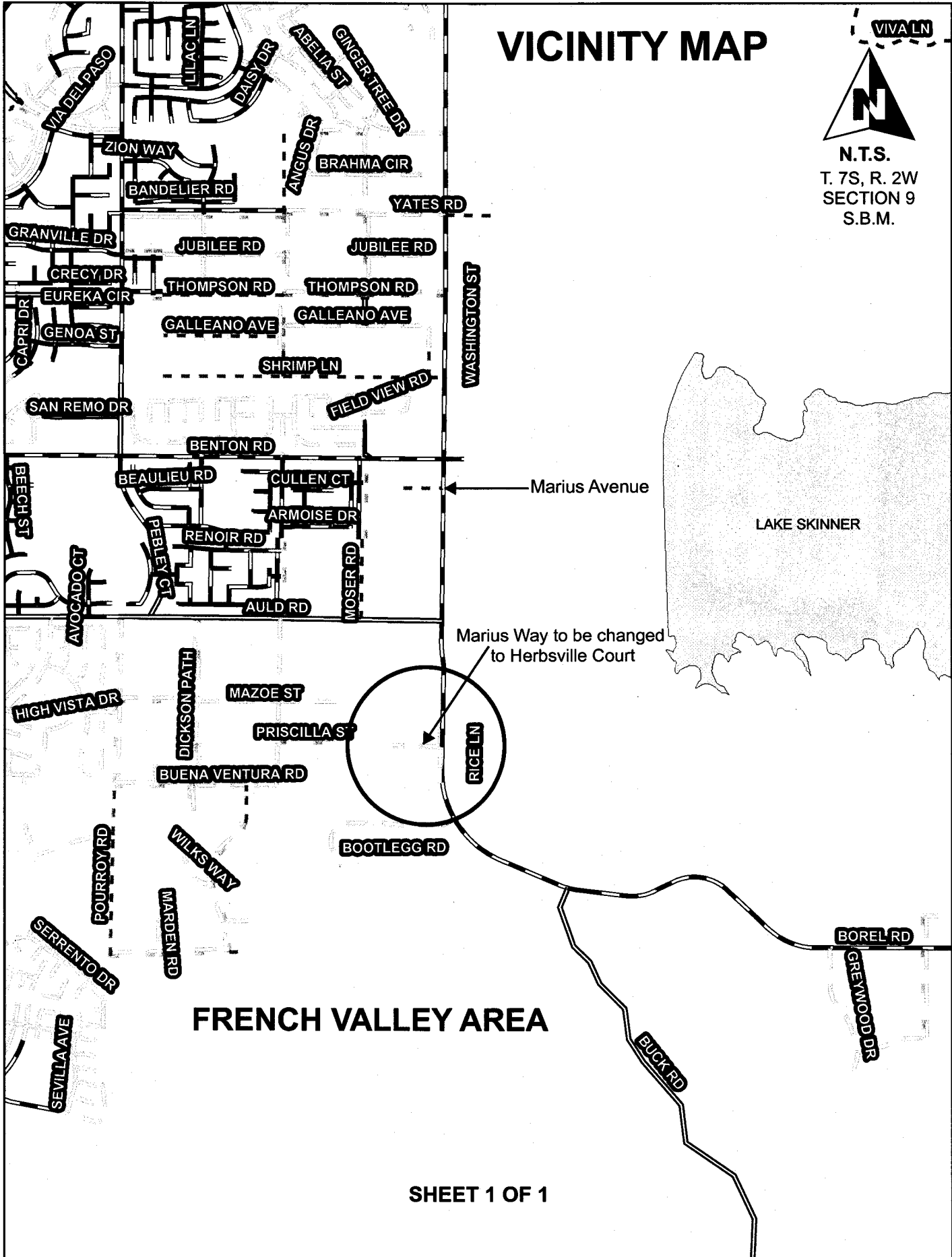
