SUBJECT: APPROVAL OF THE FIRST AMENDMENT TO THE AGREEMENT WITH RIVERSIDE TRANSIT AGENCY TO PROVIDE TROLLEY SERVICE FOR THE JURORS WITH THE COUNTY OF RIVERSIDE

RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and execute the amendment to extend the trolley service agreement with Riverside Transit Agency (RTA) for one year at an annual cost of \$155,177, with the option to renew the agreement for four additional one-year periods, and;
2. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise the renewal option, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed the annual CPI rates.

BACKGROUND: The County entered into an agreement with RTA to provide trolley service for jurors parked at remote lots. These parking lots include: Rosewood and Market Streets, Calvary Presbyterian Church at 4495 Magnolia Avenue and Eden Lutheran Church at 4725 Brockton Avenue. The County sent out an RFP (PUARC-481) to solicit interest from other transportation services. Three proposals

were received: Transportation Concept, MV Transportation, and McDonald Transit (RTA). Purchasing Department and Executive Office staff reviewed the three proposals and determined that RTA, the current provider, offers the lowest price for the trolley service.

Riverside Transit Agency (RTA) will honor the current contract cost at \$155,177 per year. The agreement will be renewed annually in one-year increments with a completion date of June 30, 2014.

CONTRACTOR: Riverside Transit Agency
Contract Term: July 1, 2009 through June 30, 2014
Effective Date of Amendment: July 1, 2009
Annual Maximum Contract Amount: \$155,177

The Agreement between Riverside County, herein referred to as COUNTY and Riverside Transit Agency, herein referred to as CONTRACTOR, is amended as follows:

1. On page 1 of the Agreement, amend Section 2 the "Period of Performance":
To amend all reference to the Period of Performance from expiration of 6/30/09 to a Period of Performance of 7/01/09 through 6/30/2010, with the option to renew, for four (4) additional years, in one (1) year increments, unless terminated as specified in Section 9 TERMINATION. All other terms of the Period of Performance in the Agreement shall apply.
2. On Page 2 of the Agreement, amend Section 3 the "Compensation":
The COUNTY agrees to pay CONTRACTOR for services performed at an annual rate of one hundred fifty-five thousand one hundred seventy-seven dollars (\$155,177.00), to be paid in twelve monthly installments of (\$12,931), including all expenses, based on the availability of fiscal funding.
3. All other terms and conditions of the Agreement are to remain unchanged.
