BACKGROUND:

Voices of Inland Communities for Health and Safety provides scholarships for vocational and occupational students in the Perris Valley. The American Cancer Society hosts an annual fundraiser each year honoring a cancer survivor and these funds provide sponsorship of the dinner. The MultiService Center for homeless in Palm Springs requires operational funds and these funds pay the City of Desert Hot Springs portion of that funding. The Riverside National Cemetery Support Committee provides an annual Concert for Heroes and these funds sponsor that event. The Riverside Philharmonic Foundation is providing a free Patriots Concert on the 4th of July and these funds sponsor that event.
