21 roads and recognizes that said roads are public roads open for use by the general

4 **BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED** that this
5 acceptance for the purpose of vesting title in the County of Riverside on behalf of the
6 public for public roads and utility uses, and is not an acceptance of the road into the
7 County Maintained Road System pursuant to Section 941 of the Streets and Highways
8 Code and that said roads will not become part of the County Maintained Road System
9 unless subsequently accepted into said Maintained Road System by a resolution adopted
10 by this Board;

13 Said roads are in the County of Riverside, California, and are described as follows:
