SUBJECT: Approve the increase to the Professional Services Agreements for temporary Dietetic Registry Staffing for Riverside County Regional Medical Center

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the increase to the annual aggregate amount of \$82,000 for the temporary Dietetic Registry Staffing agreements, and;
- 2) Approve the increase to the annual aggregate amount of \$394,000.00 to be utilized among the following Contractors as the need dictates:
 - (a) CliniPro Staffing and (b) Nutrition Ink

BACKGROUND: RCRMC and the Purchasing Department issued a formal request for proposal, MCAR013, to secure qualified temporary Dietetic Registry services at the most economical rates. The Food and Nutrition Services Department has experienced difficulty with recruitment and retention of qualified and Registered Dietitians for the past two years and continues to have vacant positions that have been classified as difficult to recruit. Therefore, it is respectfully requested that the Board grant the Purchasing Agent authority to increase the annual aggregate amount for Dietetic Registry services to make dietitians available 24 hours a day to provide medical nutrition therapy recommendations to physicians for high risk/trauma patients.

THIRD AMENDMENT TO THE AGREEMENT

WITH

CLINIPROSTAFFING
(Dietary Registry)

That certain Agreement between Riverside County Regional Medical Center (COUNTY) and Clinicprostaffing (CONTRACTOR), approved by the Riverside County Board of Supervisors on August 1, 2006, effective August 1, 2006, amended on November 6, 2007, and October 1, 2008, hereby amended effective April 1, 2009 as follows:

1. Delete the language of Section **10.0 BILLING AND INVOICING**, in its entirety and replace with the following:

“10.1 The COUNTY shall pay the CONTRACTOR for services performed and expenses incurred in accordance with Exhibit A, consisting of one (1) page attached hereto and incorporated herein. CONTRACTOR understands that the COUNTY’s budget for these services from all contractor’s providing such services, shall not exceed the aggregate amount of three hundred ninety-four (\$394,000) dollars annually. CONTRACTOR further understands that the COUNTY is not obligated to any one CONTRACTOR for any specific amount of business or dollars, and the COUNTY reserves the right to use the services of the CONTACTOR at the COUNTY’s discretion and only as needed.”


2. All other terms and conditions of this Agreement are to remain unchanged.
