SUBJECT: Substantial Amendment to the 2004-2009 Five Year Consolidated Plan

RECOMMENDED MOTION: That the Board of Supervisors amend the 2008-2009 One-Year Action Plan of the 2004-2009 Five-Year Consolidated Plan to add the following projects:

- 1. CSA 85/Cabazon Community Service Project (5.20-08) \$57,871.50
- 2. San Jacinto Street Improvements (3.SJ.01-08) \$500,000

BACKGROUND: The U.S. Department of Housing and Urban Development (HUD) requires that all substantial amendments to the Five-Year Consolidated Plan and the One-Year Action Plan be approved by the Board of Supervisors. All new activities added to the One-Year Action Plan as well as any significant increases in funding to an existing project will be considered substantial amendments. Staff recommends approval of the new projects as described in Attachment "A."

Pursuant to 24 CFR 91.105, the Economic Development Agency published a 30-day public notice notifying the public of the proposed amendments to the 2004-2009 Five-Year Consolidated Plan and the 2008-2009.
