BACKGROUND: 911 Emergency Services has requested this street name change because
there are two roads in close proximity with very similar names, Marius Avenue, and Marius Way.
The three adjacent property owners have been notified of the proposed name change and were
given the opportunity to suggest a new name for the street. Responses were received from two
property owners with suggestions for new names. All suggested names were submitted for
review and the name selected was Herbsville Court. The Transportation Department has not
received any opposition.

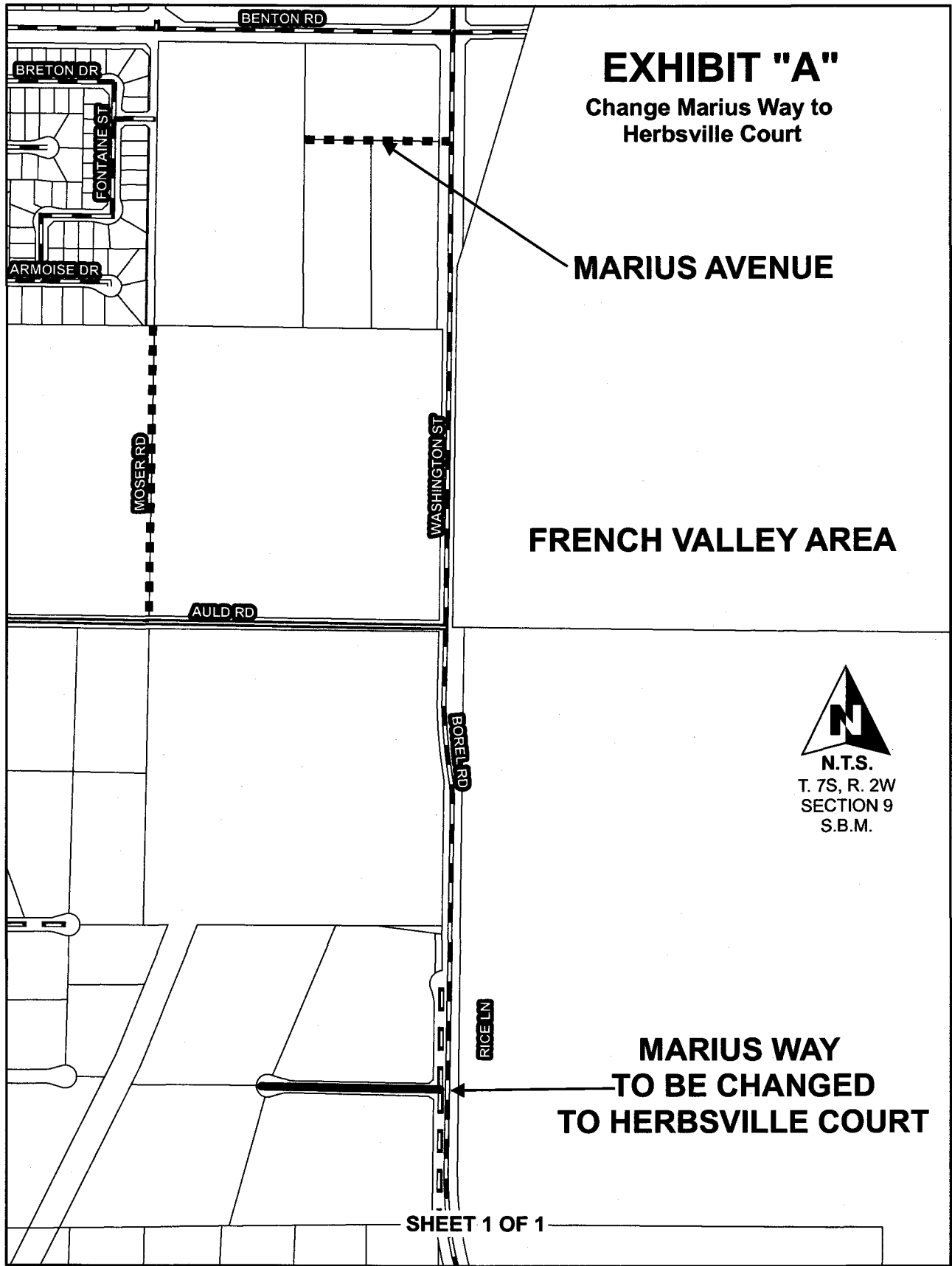

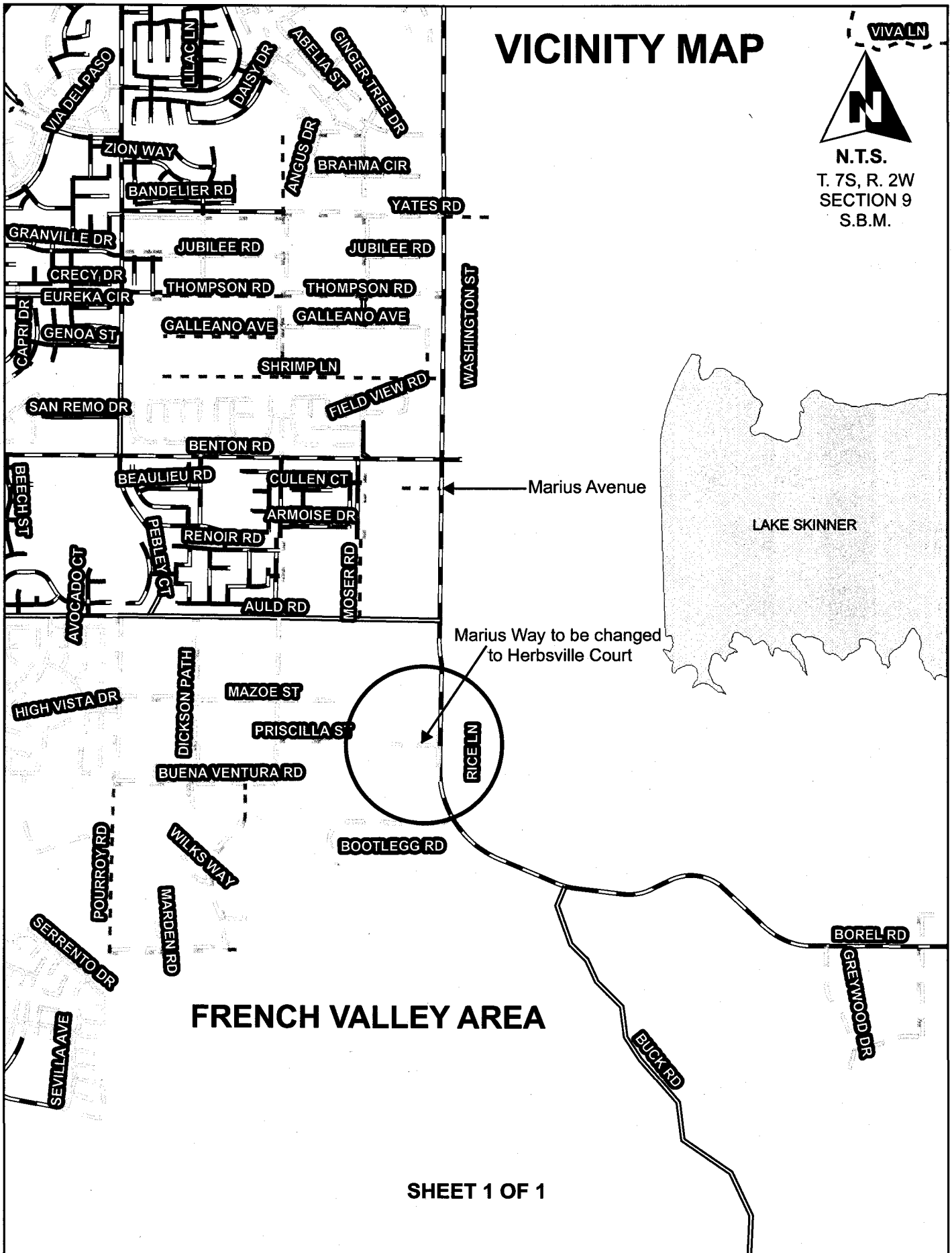
