- 1. Authorizes the Chair to execute Amendment #01 to the contract that MTGL Inc. has with the Regional Park & Open-Space District (Park District) for material testing services for the Rancho Jurupa Park Expansion - Phase 2 project; and
2. Instructs the Clerk of the Board to return four (4) executed copies of Amendment #01 to the Park District for transmittal and file.

BACKGROUND: On March 25, 2008 per Board Minute Order 13.2, your Honorable Board approved the request from the Park District to have the Clerk of the Board advertise for bids for Material Testing Services. Bids were received and publicly opened by the Clerk on April 10, 2008, with the Clerk receiving 14 bids. The low bid was submitted by MTGL, Inc., Riverside, California in the amount of \$78,350.00. SUBJECT: Execution of Amendment #01 to the Material Testing Services Agreement for the Rancho Jurupa Park Expansion – Phase 2 project with MTGL, Inc.– District II

The original estimate for material testing services needed during the duration of the contract was based on the assumption that the project would last for twelve months. The project is actually lasting longer than twelve months due to some delays in construction and a small amount of added scope.

As long as construction is progressing, the need for material testing exists. There is enough funding within the project budget to cover the cost of this amendment; therefore, the Park District requests that an amendment for \$32,000 be issued.

Charges will be consistent with the rates that MTGL, Inc. has used for the last one year of construction and are in line with reasonable, current industry standards. The Amendment amount is a not-to-exceed amount. No monies will be paid to MTGL, Inc. until the services being charged are verified by the Park District and completed.

The Office of County Counsel has reviewed and approved the amendment as to legal form.
