RECOMMENDED MOTION: That the Board of Supervisors:

1. Approve and execute the third amendment with the 19 vendors as listed in Attachment "A" for \$5,200,000 for a period of performance starting July 1, 2009 to December 31, 2009 and;
2. Authorize the Purchasing Agent, in accordance with Ordinance 459.4, to sign amendments that do not change the substantive terms of the agreement.

BACKGROUND: The Board approved on March 14, 2006, Item #3.26, the Per Diem Nurse Registry agreements based on the formal request for proposal number PUARC759. These agreements will be expired on June 30, 2009. On May 21, 2009, the Purchasing Department and RCRMC issued the formal request for qualifications (RFQ) number MCARC-104 to research the market for uniform and more economical rates. In pending to finalize the RFQ, RCRMC request a 180-day extension to the existing registry agreements to secure temporary nursing services as a measure to ensure appropriate levels of nursing staff for safe patient care and to meet licensure standards.
