BACKGROUND:

In accordance with Board of Supervisors policy number B-4, County Departments may evaluate existing rates for services on an annual basis, and make recommendations for changes. The Department last updated rates on December 11, 2007, Agenda Item 9.9. The Department has reviewed the impact of the cost of providing services relative to the rate structure, and is proposing changes to specified services provided by the Department of Animal Services.

The proposed rates are based on actual cost data, projected increases for the upcoming fiscal year and comparison with three (3) neighboring counties. The major impact of the fee changes that the Department is proposing stems from the additional costs for supplies, increase in the indirect cost rate, implementation of new ordinances, and consistency with the fee trends of neighboring counties.

The Department recognizes that additional tools are needed to stem the tide of unwanted, abandoned and neglected pets that enter the County's animal shelters. The current fiscal challenges have increased the numbers of such pets entering our system which increases maintenance and care costs for such animals. The Department's ordinance amendments will help solve pet overpopulation resulting from owners and/or custodians who fail to comply with State and local laws relating to animals.

The amendment to this Ordinance also contains fee revisions, as outlined in Exhibit "A." Currently, the cost to adopt an animal from the County is a combination of the adoption fee, rabies vaccination, microchip, de-worming medication and the cost to alter the animal. Based on these variables, the average cost is \$111. By implementing a last chance adoption rate of \$20 for dogs and \$5 for cats, this will reduce overall maintenance and care costs in addition to saving the life of an adoptable animal.

Recommended fees reflect a slight loss to the County (see Exhibit B); however, charging the actual costs to an owner retrieving an impounded animal would result in a larger decrease of revenue, as owners would not have the financial ability to redeem their animals.

FINANCIAL DATA

These proposed fees have been reviewed and approved by the County Auditor/Controller. If approved by the Board of Supervisors, the fee adjustments will result in revenue to the Department. No budget adjustment is requested at this time due to increased revenue will not result in net revenue increase for FY 08/09 Budget. FY 09/10 Budget has been submitted and reflects these increases.
