**SUBJECT:** American Recovery and Reinvestment Act (ARRA) Program Year 2009-2011 funding recommendations for community college class size training.

**RECOMMENDED MOTION:** That the Riverside County Board of Supervisors:

1. Approve ARRA funding in the amount of \$4,441,400 for Program Year 2009-2011 Riverside County Community College class size training projects; and
2. Authorize the Director of Workforce Development to negotiate and execute the agreements with College of the Desert, Mt. San Jacinto Community College and Riverside Community College District for class size training. All contracts will be approved by County Counsel prior to execution.

**BACKGROUND:** The American Recovery and Reinvestment Act of 2009 provides local workforce investment areas the opportunity to contract directly with institutions of higher education, including community colleges. On April 30, 2009 solicitations were sent to local community colleges in Riverside

**BACKGROUND:** (Continued)

County requesting proposals for class size curriculum training in the Workforce Investment Board's targeted industries. The targeted industries of healthcare, renewable energy, utilities, professional business services, and infrastructure were determined to be recession resistant or emerging industries in Riverside County. Each college responded with multiple proposals for the training, and upon review, the following funding recommendations are presented for approval:
