BACKGROUND: On November 18, 2008 by Minute Order 13.1 your Honorable Board approved a contract between the District and Harris Miniature Golf Inc., Wildwood, New Jersey for the construction of a miniature golf course for Rancho Jurupa Park.

The original contract price was \$439,500.00. A total of one change order was written in the amount of \$3,667.53 changing the total contract price to \$443,167.53. The change order was written for items added by the District to the scope of work.

All work has been satisfactorily completed and is in compliance with the contract documents.
