SUBJECT: Amendment to the Agreement between the County of Riverside and the California Perinatal Quality Care Collaborative (CPQCC)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Amendment to the Agreement with CPQCC, effective January 1, 2009;
- 2) Authorize the Chairperson to sign two (2) copies of the amendment;
- 3) Retain one (1) copy and return one (1) copy of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: As a condition of participation with the California Children's Services (CCS) program, RCRMC is required to provide hospital-level performance data of services provided in the Hospital's Perinatal and Neonatal intensive Care Units. This data is used to improve performance in perinatal care and intensive care units. The annual cost of participation in this collaborative has increased to \$5,500 effective January 1, 2009.
