SUBJECT: Fiscal Year 2009–2010 Medical Services Agreements with Contracted Clinics for the Medically Indigent Services Program (MISP)

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the Medical Services Agreements for the County Network Clinics for the period of July 1, 2009, through June 30, 2010;
- 2) Authorize the Chairperson to sign three (3) copies of each Agreement; and
- 3) Direct the Clerk of the Board to retain one (1) original of each Agreement and return two (2) fully executed originals of each Agreement to Riverside County Regional Medical Center, Administration.
- 4) Authorize the Purchasing agent to renew these agreements annually for up to three one-year periods in amounts not to exceed the program budget limits.

BACKGROUND: The Contracted Clinics provide necessary medical treatment services to MISP eligible patients. The fiscal year 2009-2010 Agreements are equivalent to previous annual contracts. Maximum annual compensation per agreement is noted on Page 2.

Maximum Annual Compensation, per Agreement:

Borrego Community Health Foundation	\$ 50,000
Clinicas De Salud Del Pueblo, Inc. / Blythe Family Health Clinic	\$ 55,000
Desert AIDS Project	\$120,000
Mecca Health Clinic	\$ 55,000
Neighborhood Health Care (Temecula)	\$ 45,000
Indio Emergency Medical Group, dba Santa Rosa del Valle Medical Group	\$ 55,000
Riverside / San Bernardino County Indian Health, Inc.	<u>\$ 5,000</u>
Total:	<u>\$385,000</u>

If necessary, these dollar amounts may be reallocated amongst the clinics as long as the total payments do not exceed \$385,000.

MISP pays medical claims to the clinics under approval of a previous Form 11 approved under Agenda Item No. 3.33, dated 10/25/2008 which authorizes MISP to pay medical services without securing competitive bids in accordance with Ordinance 4594.4.

These agreements secure a price per visit and set the maximum annual compensation per fiscal year.

The Agreements have been approved as to form by County Counsel.
