SUBJECT: Amendment of the Radiation Therapy Medical Services Agreement between the County of Riverside and Valley Radiotherapy Associates Medical Group, Inc.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Ratify the amendment to the radiation therapy medical services agreement effective July 1, 2009; and
- 2) Authorize the Chairperson to execute three (3) copies of the amendment; and
- 3) Retain one (1) copy of the executed amendment and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) Administration for distribution.

BACKGROUND: Effective January 1, 2005, an agreement was signed with Valley Radiotherapy Associates Medical Group to provide radiation therapy at offices locations throughout the County of Riverside for patients referred by the hospital radiation therapy medical services. Radiation therapy medical services are not available on-site at the Hospital. This amendment revises the language of the agreement to an annual renewal.

VALLEY RADIOTHERAPY ASSOCIATES MEDICAL GROUP



1. Delete Section 2.1. TERM in its entirety and replace with the following:

"This Agreement shall be effective as of January 1, 2005 and automatically continue on a year-to-year basis, unless terminated as otherwise provided herein."
