BACKGROUND: Effective February 1, 2007 Indio Surgery Center agreed to provide dental screening, treatment and education services to children under five (5) years of age as part of the First 5 Dental Grant awarded to RCRMC. This amendment revises the language of the agreement to an annual renewal for the term of the dental grant.

1. Delete Section 2.1. TERM in its entirety and replace with the following:


“This Agreement shall be effective as of May 1, 2006 and automatically continue on a year-to-year basis, unless terminated as otherwise provided herein.”


