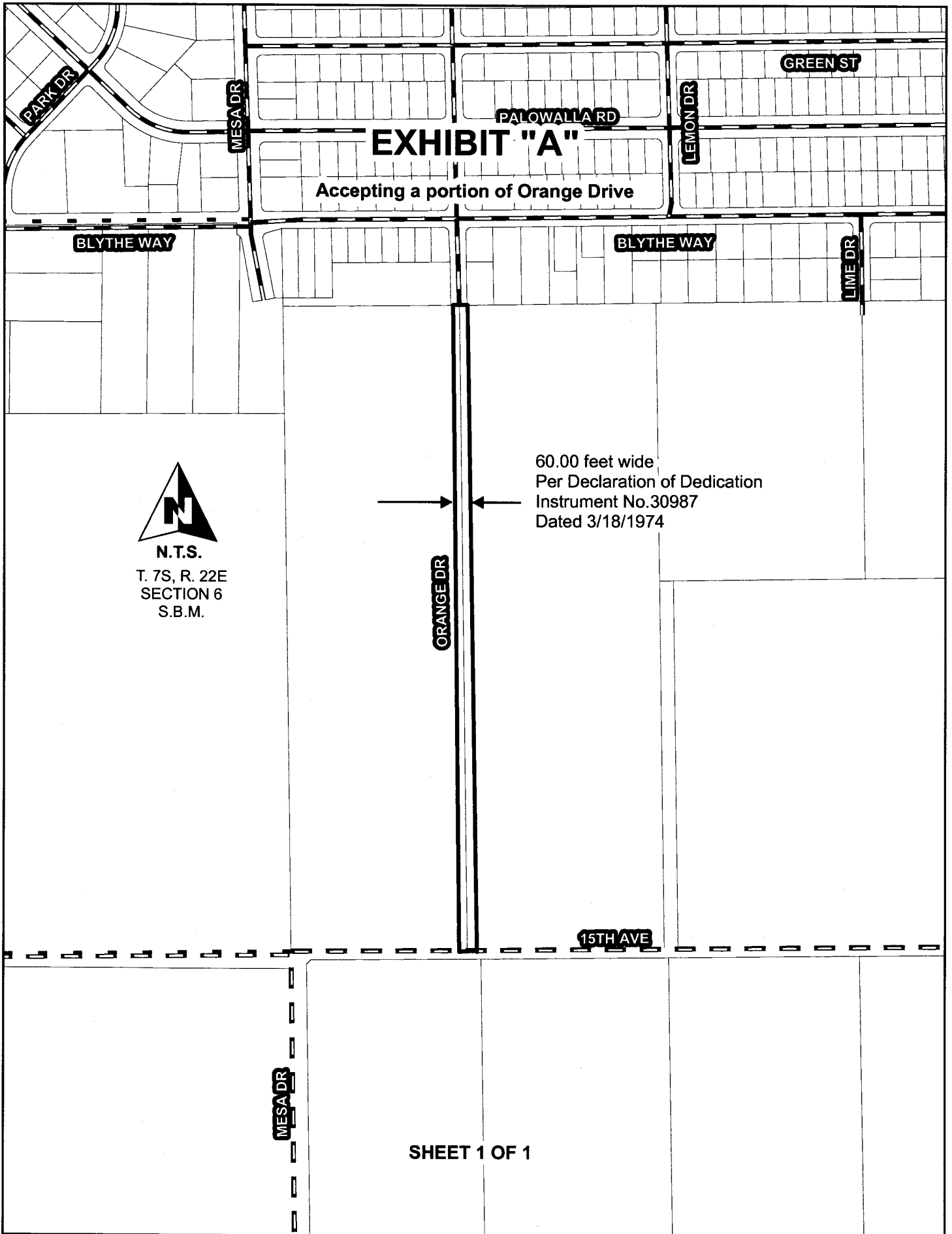

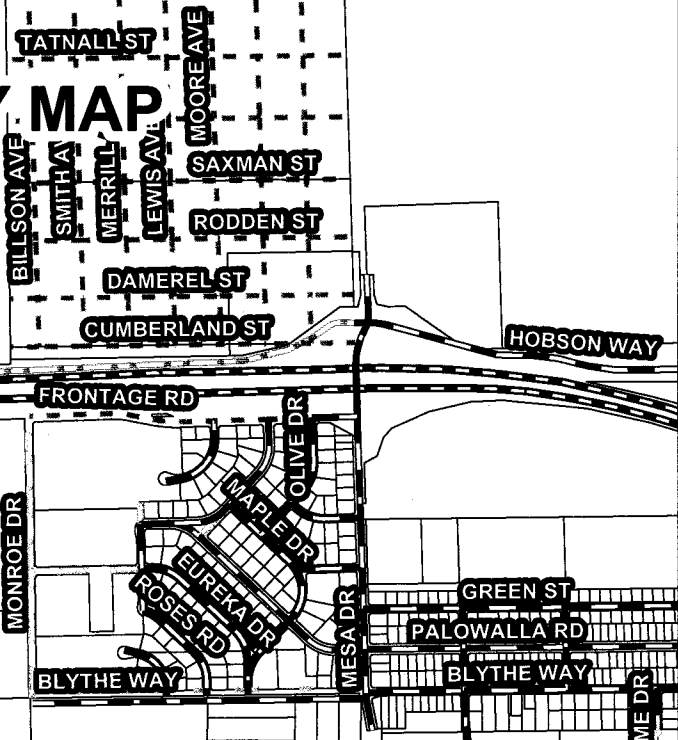
Accepting a portion of Orange Drive

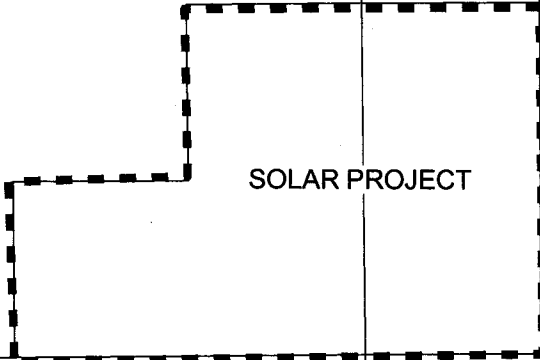
