SUBJECT: Recommendation for Distribution of Excess Proceeds for Tax Sale No. 176, Item 123.
Last assessed to: Stephen A. Szabo and Esther F. Szabo, husband and wife as joint tenants.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the claim from Global Discoveries, Ltd., assignee for Myles J. Szabo, Successor Trustee of the Inter Vivos Trust Estate of Stephen A. Szabo and Esther F. Szabo, last assessee's for payment of excess proceeds resulting from the Tax Collector's public auction sale associated with parcel 374031009-7;
- 2) Authorize and direct the Auditor-Controller to issue a warrant to Global Discoveries, Ltd., assignee for Myles J. Szabo, Successor Trustee of the Inter Vivos Trust Estate of Stephen A. Szabo and Esther F. Szabo in the amount of \$30,180.63, no sooner than ninety days from the date of this order, unless pursuant to the California Revenue and Taxation Code Section 4675, an appeal has been filed in Superior Court.

BACKGROUND: In accordance with Section 3691 et seq. of the California Revenue and Taxation Code, and with prior approval of the Board of Supervisors, the Tax Collector conducted the March 13, 2006 public auction sale. The deed conveying title to the purchasers at the auction was recorded May 3, 2006. Further, as required by Section 4676 of the California Revenue and Taxation Code, notice of the right to claim excess proceeds was given on June 5, 2006, to parties of interest as defined in Section 4675 of said code. Parties of interest have been determined by an examination of lot book reports as well as Assessor's and Recorder's records, and various research methods were used to obtain current mailing addresses for these parties of interest.



The Treasurer-Tax Collector has received one claim for excess proceeds:

- 1) Claim from Global Discoveries, Ltd., assignee for Global Discoveries, Ltd., assignee for Myles J. Szabo, Successor Trustee of the Inter Vivos Trust Estate of Stephen A. Szabo and Esther F. Szabo based on an Assignment of Right to Collect Excess Proceeds dated February 28, 2007, an Indenture recorded January 25, 1961 as Book No. 2838 and Page No.143, a Declaration of Trust of Dr. and Mrs. Szabo dated July 28, 1959, an Order Appointing Successor Trustee of Inter Vivos Trust to Fill Vacancy filed January 26, 1982 and the death certificate's of Stephen Alvin Szabo and Esther Fox Szabo.

Pursuant to Section 4675 (a) & (b) of the California Revenue and Taxation Code, it is the recommendation of this office that Global Discoveries, Ltd., assignee for Myles J. Szabo, Successor Trustee of the Inter Vivos Trust Estate of Stephen A. Szabo and Esther F. Szabo be awarded excess proceeds in the amount of \$30,180.63. Supporting documentation has been provided. The Tax Collector requests approval of the above recommended motion.
