**SUBJECT:** Reimbursement for Net Cost of Services During the Transition Year for Proposed City Incorporations.

**RECOMMENDED MOTION:** That the Board, consistent with past incorporations and pursuant to Government Code section 57384(b):

1. Request reimbursement for net cost of services provided during the transition year for the proposed incorporations of Eastvale and Jurupa Valley; and
2. Issue a standing request for reimbursement for net cost of services providing during the transition year for all future incorporation proposals, unless superseded by subsequent action by this Board.

**BACKGROUND:** Government Code Section 57384 (a) requires a county to continue, without additional charge, all services previously furnished to the area within the boundary of a newly incorporated city for the remainder of the fiscal year during which the incorporation became effective. The city council can request discontinuance of the services prior to the end of the fiscal year. Government Code Section 57384 (b) also provides that the county may request reimbursement for the net cost of these services during the transition period. If requested, the city is obligated to reimburse the county for the net cost of these services within five years of the effective date of the incorporation, or for a longer period if approved by the Board of Supervisors.
