**SUBJECT:** Approval of the Homelessness Prevention and Rapid Re-Housing Program (HPRP) Subgrantee Agreement between the County and the Housing Authority of the County of Riverside.

**RECOMMENDED MOTION:** That the Board of Commissioners:

1. Approve the attached HPRP Subgrantee Agreement between the County and the Housing Authority of the County of Riverside;
2. Authorize the Chairman of the Board to execute the said attached HPRP Subgrantee Agreement.

**BACKGROUND:** On May 12, 2009, the Board approved the Substantial Amendment to the 2008-2009 One Year Action Plan that added the \$4,276,900 of HPRP funds. The primary purpose of the HPRP is to provide homelessness prevention assistance and services to households that would otherwise become homeless – many due to economic circumstances – and to provide assistance to rapidly “re-house” and stabilize those that are homeless. The U.S. Department of Housing and Urban Development (HUD) approved the County’s HPRP Substantial Amendment and the “request for waiver for good cause” to allow the Housing Authority to serve as the HPRP Subgrantee.
