SUBJECT: Prevent Child Abuse Riverside County (PCARC) 2007 Annual Report

BACKGROUND:

On June 05, 2007 (Agenda Item #3.52), the Board re-designated PCARC as the lead Child Abuse Prevention Coordinating Council.

Child Abuse Prevention Coordinating Councils receive funding pursuant to Section 18981 of the Welfare and Institutions Code (WIC), to coordinate community efforts to prevent and respond to child abuse. Prevent Child Abuse of Riverside County (PCARC) serves as the lead agency working with the regional child abuse prevention collaboratives to accomplish this goal.

Pursuant to the Agreement between PCARC and the Department of Public Social Services (DPSS) and in compliance with the Welfare and Institutions Code (WIC) Section 18983.6, PCARC is required to submit an annual report of its operations and accomplishments to the Board. Therefore, the Director of DPSS requests that the Board receive and file the attached report for Fiscal Year 2008/2009.
