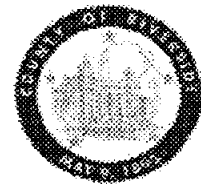

RECOMMENDED MOTION: Move that:

Departmental Concurrence

- (1) The substandard structure (dwelling) on the real property located at 28751 10th Street, Lake Elsinore, Riverside County, California, APN 347-202-002 be declared a public nuisance and a violation of Riverside County Ordinance No. 457, which does not permit substandard structures on the property.
- (2) Diane L. Bock, the owner of the subject real property, or whoever has possession or control of the subject real property, be directed to abate the substandard structure on the property by rehabilitating, removing and/or demolishing the same from the real property, including the removal and disposal of all structural debris and materials, within ninety (90) days.

- (3) The owner or whoever has possession or control of the subject real property be ordered to ascertain the existence or non-existence of asbestos containing materials in said structure by survey and materials sample testing through the Industrial Hygiene Specialist of the County Health Department, Division of Special Services; and, prior to the abatement ordered in paragraph number two (2) above, to secure the removal and disposal of all asbestos containing materials discovered through such survey and testing by contract with a duly certified and licensed contractor for the handling of such materials to avoid citations and/or fines imposed by the South Coast Air Quality Management District (SCAQMD) pursuant to SCAQMD Rule No. 1403.
- (4) The accumulation of rubbish on the real property located at 28751 10th Street, Lake Elsinore, be declared a public nuisance and a violation of Riverside County Ordinance No. 541, which does not permit the accumulation of rubbish on the property.
- (5) Diane L. Bock, the owner of the subject property or whoever has possession or control of the subject real property, be directed to abate the accumulation of rubbish on the property by removing and disposing of the same from the real property within ninety (90) days.
- (6) If the owner or whoever has possession or control of the subject real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or their representatives, receipt of a Court Order authorizing entry onto the real property, or other authorization as provided by law, shall abate the substandard structure and the accumulation of rubbish by removing and disposing of the same from the real property
- (7) The reasonable cost of the abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Ordinance No. 725.
- (8) County Counsel be directed to prepare the necessary Findings of Fact and Conclusions of Law that the substandard structure on the real property and the accumulation of rubbish are declared to be in violation of Riverside County Ordinance Nos. 457 and 541 and constitute a public nuisance. Further, County Counsel shall prepare an Order to Abate for approval by the Board.

JUSTIFICATION:

1. An initial inspection was made of the subject real property by the Code Enforcement Officer on November 8, 2007.
2. The inspection revealed a substandard structure (one story dwelling) on the subject real property in violation of Riverside County Ordinance No. 457. The substandard conditions of the structure included, but were not limited to the following: lack of hot and cold running water to plumbing fixtures; lack of required electrical lighting; hazardous and exposed wiring; lack of adequate heating facilities; sagging and caved in ceiling; dampness of inhabitable rooms; faulty weather protection; general dilapidation and improper maintenance; fire hazard; abandoned, vacant, and public and attractive nuisance. The inspection also revealed the accumulation of rubbish (approximately 6,969 square feet) on the subject property in violation of Riverside County Ordinance No. 541. The accumulation of rubbish consisted of, but was not limited to the following materials: a wrecked horse trailer, scrap wood, scrap metal, aluminum, plastic cones, partial metal shed,

refrigerators, furniture, appliances, chicken wire, metal cages, tires, metal barrels, exercise equipment, a large wooden spindle, green waste, cardboard, and paper.

3. Subsequent inspections of the above-described real property on August 7, 2008; March 19, 2009; and July 23, 2009 revealed that the property continues to be in violation of Riverside County Ordinance Nos. 457 and 541.
4. Staff and the Code Enforcement Department have complied with the requirements set forth in the appropriate laws of this jurisdiction pertaining to the Administrative Abatement Proceedings for substandard structure and accumulation of rubbish.
