9 **WHEREAS**, the hereinafter described roads were offered for dedication for public road
10 and utility purposes by the documents hereinafter-referred to, which offers of dedication have
11 not been previously accepted for public use by the County of Riverside, now, therefore;

13 **BE IT RESOLVED, DETERMINED AND ORDERED** by the Board of Supervisors of
14 the County of Riverside, State of California, in regular session assembled on _____ ,
15 2009, that this Board accepts the offers of dedication and recognizes that said road is a
16 public road open for use by the general public;

18 **BE IT FURTHER RESOLVED, DETERMINED, AND ORDERED** that this acceptance
19 is for the purpose of vesting title in the County of Riverside on behalf of the public for public
20 road and utility purposes, and is not an acceptance of the road into the County Maintained
21 Road System pursuant to Section 941 of the Streets and Highways Code and that said road
22 will not become part of the County Maintained Road System unless subsequently accepted
23 into said Maintained Road System by a resolution adopted by this Board;

10 (30.00 feet wide) designated as Lots "A" through "C" inclusive, filed in Book 210, Pages 52
11 and 53 of Parcel Maps, Records of Riverside County, California, and excepting, therefrom,
12 that portion lying in Parcel map No. 18067, (30.00 feet wide) designated as lots "A" through
13 "D" inclusive, filed in Book 105, Pages 10 and 11 of Parcel Maps, Records of Riverside
