SUBJECT: Approval of the Amendment to the Agreement between the County of Riverside and Moreno Valley Unified School District

RECOMMENDED MOTION:

BACKGROUND: Riverside County Regional Medical Center was awarded a grant from the Asthma and Allergy Foundation (AAFA) to provide an asthma treatment and education programs at school sites in a Mobile Clinic setting. The Moreno Valley Unified School District has requested the Mobile Clinic provide asthma treatment and education services at specific school sites for an additional year in their district. This amendment extends the agreement effective July 1, 2009 through June 30, 2010.

FIRST AMENDMENT TO THE MOBILE CLINIC SERVICES AGREEMENT BETWEEN THE COUNTY OF RIVERSIDE AND MORENO VALLEY UNIFIED SCHOOL DISTRICT

That certain Agreement, by and between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and the Moreno Valley Unified School District. (DISTRICT), is hereby amended effective July 1, 2009, as follows:

- 1. Amend the language of Section 2.0. TERM AND TERMINATION to include the following:

"This Amendment extends the term of the Agreement from July 1, 2009 through June 30, 2010, unless renewed by mutual agreement or terminated as specified below in Section 2.2 or as otherwise provided herein."

All other terms and conditions of this Agreement are to remain in full force and effect.
