SUBJECT: Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Loma Linda University School of Dentistry/Special Care Dentistry

RECOMMENDED MOTION:

- 1) Ratify the Amendment to the Agreement with Loma Linda University School of Dentistry/Special Care Dentistry, effective July 1, 2009;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: On August 1, 2008, Loma Linda University School of Dentistry/Special Care Dentistry agreed to provide dental screening, anesthesia, treatment and education services to children under five (5) years of age as part of the First 5 Dental Grant awarded to RCRMC. This amendment revises the rate of payment for general anesthesia professional services provided as part of the dental grant.


9 That certain Agreement between the County of Riverside, on behalf of




