**SUBJECT:** Approval of the Amendment to the Professional Medical Services Agreement between the County of Riverside and Vahe Sam Sardaryanst, D.D.S, M.P.H.

**BACKGROUND:** On February 1, 2008, Vahe Sam Sardaryanst, D.D.S., M.P.H. agreed to provide dental screening, treatment and education services to children under five (5) years of age as part of the First 5 Dental Grant awarded to RCRMC. This amendment revises the rate paid for general anesthesia provided as part of the dental grant.
