**SUBJECT:** Amendment to the Per Diem Hospital Agreement between the County of Riverside and Inland Empire Health Plan ("IEHP")

**RECOMMENDED MOTION:** That the Board of Supervisors:

- 1) Ratify the Amendment to the Riverside County Regional Medical Center (RCRMC) hospital agreement with the IEHP effective October 1, 2008;
- 2) Authorize the Chairperson to sign three (3) copies of the Amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed Amendment to Riverside County Regional Medical Center (RCRMC) for distribution.

**BACKGROUND:** On June 19, 1996, Agenda No. 3.24, the Board of Supervisors approved the hospital per diem agreement between RCRMC and IEHP to provide Hospital services. The First Amendment allowed RCRMC to participate in a supplemental Managed Care payment program which will provide additional funding to public hospitals. A Second Amendment added language to ensure funds are appropriately tracked and retained by the Hospital for health care service. The Third Amendment adds language at the direction of the Centers for Medicare and Medicaid Services (CMS) to ensure funds are expended by the Hospital.

THIRD AMENDMENT  
TO THE HOSPITAL PER DIEM AGREEMENT  
BETWEEN  
INLAND EMPIRE HEALTH PLAN  
AND  
RIVERSIDE COUNTY REGIONAL MEDICAL CENTER

WHEREAS, the Inland Empire Health Plan (“IEHP”), IEHP Health Access (“Health Access”) (known collectively as “IEHP HEALTH PLAN”), and RIVERSIDE COUNTY REGIONAL MEDICAL CENTER (“HOSPITAL”) agree to amend the Hospital Per Diem Agreement, as amended, between them dated April 1, 2007, (the “Agreement”);

NOW THEREFORE, the parties agree as follows:

- A. The First Amendment and its Exhibit C2 IGT SUPPLEMENTAL PAYMENT to this contract, effective September 1, 2008, is hereby amended to delete any and all references to the effective date September 1, 2008, which shall be replaced with the effective date of October 1, 2008.
- B. The language of Exhibit C2 IGT SUPPLEMENTAL PAYMENT, Section B. Conditions for Receiving Supplemental Payments, Subsection (5) is hereby deleted in its entirety and replaced with the following statement:

“(5) (a) The LMSPs shall represent compensation for services rendered to Medi-Cal Plan Members for Medi-Cal services by HOSPITAL during the State fiscal year to which the LMSP applies.

(b) To the extent that total payments received by HOSPITAL in any State fiscal year under this Agreement exceed the cost of services provided to PLAN members by HOSPITAL during that fiscal year, any remaining LMSP amounts shall be retained by HOSPITAL to be expended for health care services. HOSPITAL may use retained LMSP amounts in either the State fiscal year received or subsequent State fiscal years. (2) For purposes of subsection (1) (a) above, if the LMSPs are not used by HOSPITAL in the State fiscal year received, retention of funds by HOSPITAL will be established by demonstrating that the retained earnings account of HOSPITAL at the end of any State fiscal year in which it received payments based on LMSPs funded pursuant to the Intergovernmental Agreement, has increased over the unspent portion of the prior State fiscal year’s balance by the amount of LMSPs received, but not used. These retained HOSPITAL funds may be commingled with other County funds for cash management purposes provided that such funds are appropriately tracked and only the depositing facility is authorized to expend them.”

- C. Notwithstanding the date of execution, unless otherwise referenced, this Third Amendment shall be effective October 1, 2008 and shall terminate on September 30, 2009.
- D. All other terms and conditions of the Agreement, as amended, are to remain in full force and effect.
- E. HOSPITAL certifies that the individual signing herein has authority to execute this Amendment on behalf of HOSPITAL, and may legally bind HOSPITAL to the term and conditions of this Amendment, and any attachments hereto.
