SUBJECT: State Legislative Advocacy Services

RECOMMENDED MOTION: That the Board of Supervisors approve and authorize the Chairman to sign one year extensions of the agreements with Michael Y. Corbett and Nielsen, Merksamer, Parrinello, Mueller and Naylor for state legislative advocacy services.

BACKGROUND: Since 2003 the County has used a variety of contractors to provide a bipartisan state lobbying team, with Michael Corbett serving as the Sacramento-based legislative coordinator. The team, working with Board members and staff has effectively promoted the County's positions and has established productive relationships with legislators and administrative officials. The attached agreements will continue all current services. Each was prepared with a ten percent (10%) reduction to the compensation.


