SUBJECT: Ordinance No. 348.4672, an ordinance of the County of Riverside amending Ordinance No. 348 regarding churches, temples or other places of religious worship in the R-R zone

RECOMMENDED MOTION: That the Board introduce and adopt, on successive weeks, Ordinance No. 348.4672.

BACKGROUND:

On October 14, 1997 (Item 12.5) the Board of Supervisors approved an amendment to Ordinance No. 348 allowing churches, temples or other places of religious worship to be processed with either a plot plan or public use permit in certain zones, while also eliminating churches, temples or other places of religious worship as a conditionally permitted use in other zones. Of particular importance, the Board's approval allowed a church, temple or other place of religious worship to be processed with an a plot plan in the R-R (Rural Residential) zone.

On August 10, 1999 (Item No. 3.33) the Board of Supervisors adopted Ordinance No. 348.3883 which was intended to implement the Board's October 14, 1997 decision. Ordinance No. 348.3883 specifically amended Ordinance No. 348 to allow churches, temples or other places of religious worship in the R-R zone with a plot plan. Numerous editorial errors were discovered in Ordinance No. 348.3883 after its adoption.

Subject: Ordinance No. 348.4672

On September 21, 1999 (Item 3.23) the Board of Supervisors adopted Ordinance No. 348.3888 repealing Ordinance No. 348.3883. Adoption of Ordinance No. 348.3888 was intended to correct the editorial errors in Ordinance No. 348.3883 and accomplish the changes approved by the Board on October 14, 1997.

We have now discovered Ordinance No. 348.3888 inadvertently failed to add a subsection to Section 5.1.b. of Article V of Ordinance No. 348 to allow churches, temples and other places of religious worship as a permitted use with a plot plan in the R-R zone. As stated above, both the October 1997 Board action and Ordinance No. 348.3883 allowed churches, temples and other places of religious worship in the R-R zone. Adoption of Ordinance No. 348.4672 will correct the editorial error.
