BACKGROUND: On September 1, 2009, the County entered into a contract with Team West Contracting Corp., for the construction of the Apron Rehabilitation Project for the French Valley Airport. The project consisted of rehabilitating and sealing the aircraft holding apron located on the aircraft tie-down areas and airport Fixed Base Operator (FBO) Leaseholds. The project was completed on November 18, 2009, and the airport has been returned to its full operational capacity.
